

## PAObank Motor Insurance Limited Time Offer Terms and Conditions

These terms and conditions must be read in conjunction with our Retail Services Terms and Conditions. These terms and conditions do not apply to any existing product(s) or service(s) you have with us to the extent that they are subject to separate terms and conditions.

- 1. "Designated Insurance Product" means the motor insurance issued by China Ping An Insurance (Hong Kong) Co., Ltd.
- 2. China Ping An Insurance (Hong Kong) Co., Ltd. ("China Ping An") reserves the right to decline applications for the Designated Insurance Product with a full refund of any premium paid and any insurance levy paid without interest. The policies of Designated Insurance Product are subject to the respective policies' terms and conditions. Please refer to the relevant product brochure and policy provisions for details. For the actual premium discount, please refer to the terms and conditions on the insurance product page of PAObank App.
- 3. The promotion period is valid from 18 October 2025 to 22 November 2025 ("Promotion Period").
- 4. During the Promotion Period and subject to these terms and conditions, first 100 customers who apply for the Designated Insurance Product via PAObank App with a gross premium of HKD4,500 or above may be eligible for a premium discount of HKD1,388 ("Offer").
- 5. The Offer is only applicable if the following requirements are satisfied:
  - the application must be successfully submitted through PAObank App during the Designated Promotion Period; and
  - The application of the Designated Insurance Product must be accepted by China Ping An, and the relevant discounted premium and insurance levy must be fully paid on or before the relevant deadline as required by China Ping An.
- 6. After issuance of the policy of the Designated Insurance Product, the policyholder must maintain the Designated Insurance Product policy until expiry of the Designated Insurance Product policy.
